

Per ANSI ESD S20.20 paragraph 6.1.3.1 "A Compliance Verification Plan shall be established to ensure the organization's compliance with the requirements of the Plan. Formal audits ... shall be conducted ... that identifies the requirements to be verified, and the frequency at which those verifications must occur. Test equipment shall be selected to make measurements." Per paragraph 6.1.3.2. "Verifications should include routine checks of the Technical Requirements. The frequency of verification checks should be based on the control item usage, its durability and associated risk of failure."

After six years and more than 20 drafts in the making, ANSI/ESD-S20.20-1999 looks to be the final standard covering the development of an ESD control program. This standard has replaced MIL-STD 1686 and can easily be substituted for EIA-625 ESD Control Standards.



Great Item for Field Service Personnel







comprehension and training adequacy. See paragraph 6.1.2.1 in the ESD Association's Standard ANSI/ESD S20.20.
